*The Macomb Batterers' Intervention Program's mission and focus is to promote partner safety and ending the use of domestic violence. The program focuses on the totality of the abusive behavior, accountability of the harm done to others and learning new skills.*

- The men's program meets the State Standards for batterer's intervention
- The men's program meets Mondays at 6:00pm, Thursdays at 6:00pm and Saturdays at 10am
- The women's group meets Wednesdays at 6:00pm
- Fee is \$80 intake and \$30 per session, but may be reduced with the approval of the probation officer

The Macomb Community Domestic Violence Council recommends Batterer Intervention Programs as the only appropriate intervention for batterers. These programs should be a minimum of 26 sessions and comply with the Michigan State Standards for batterer's intervention.

Looking for ideas on how to integrate Batterer Intervention Programs into your response to domestic violence? We can help with that. Our District Court Taskforce developed recommendations for best practices, including pre-sentence assessment.

- Fees are \$70 intake and \$30 per group; alternate arrangements are possible

### **Batterer Intervention vs Anger Management**

Research tells us that Batterer Intervention Programs are the best way to stop battering behaviors. When people who batter are sent to anger management instead of a batterer intervention program, the outcomes are worse for everyone. For example, “those who completed anger management programs recidivated at higher rates than those who completed batterer intervention programs, even though those referred to batterer intervention programs had significantly more criminal history, including more past order violations, more long-standing substance abuse histories, and less education than those referred to anger management programs.”
